Long Term Care (default): Long Term Care (LTC) includes the Alzheimer's Care Center, Glenridge and Gray Birch. About 250 residents call these places home and, in the face of COVID-19, our amazing staff truly took on the role as family.

What the money will be used for: LTC will use funds raised to enhance and upgrade the activities areas at Gray Birch and Glenridge, and upgrade and repair the outdoor paths and gardens at the Alzheimer's Care Center.



Employee Education Fund: Education is one of the most effective ways for MaineGeneral to remain on the leading edge of exceptional patient care. All employees, clinical and non-clinical, are encouraged to use the Employee Education Fund to further develop their skills.

What the money will be used for: Your gift will help provide financial support to your MGH colleagues, enabling them to participate in professional development opportunities.
